I hereby declare that out of the powers and functions vested in me in my capacity as the Minister of Agriculture, Rural Economic Affairs, Livestock Development, Irrigation and Fisheries and Aquatic Resources Development of the Democratic Socialist Republic of Sri Lanka, powers and functions specified in the following schedule are delegated to the State Minister of Agriculture, Irrigation and Rural Economic Affairs Wasantha Lakshminath Aluwihare in terms of provisions of the Article 44(5) of the Constitution and he has the opportunity of inquiring, mediating and co-ordinating all functions coming within the scope of work of this Ministry.
