#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### REVOCATION UNDER SECTION 39(1)

By the Order made under the Proviso (a) to Section 38 of the Land Acquisition Act (Chapter 460) and published in the *Gazette Extra Ordinary* No. 2036/3 dated 11.09.2017, and the land specified morefully in the Order No. 216 of 2017 dated 28.08.2017 was vested in the Democratic Socialist Republic of Sri Lanka.
