#### THE LAND ACQUISITION ACT (CHAPTER 460)

#### **Declaration under Section 5**

I, Gayantha Karunatilleke, Minister of Lands & Parliamentary Reforms, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below are needed for a public purpose and will be acquired under the provisions of that Act.

The allotments of below mentioned land lots 21 total extent of about 0.7107 Hectare, depicted in the Advance Tracing No. CO/HNW/2017/427 dated of 21.12.2017 prepared by the Surveyor General, situated in the Villages of Weragolla and Hingurala in the Divisional Secretary's Division of Seethawaka in Colombo District in Western Province and bounded as follows:
