THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Gayantha Karunatileke, Minister of Lands & Parliamentary Reforms, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

An allotments of land depicted in the Advance Tracing Plan No. KE/MWN/2018/119 and dated 28.09.2018 prepared by the Surveyor General, situated at the Villages of Wadiyathenna and Madulbowa in No. 39A Wadiyathenna Grama Niladhari Division and No. 39B, Madulbowa Grama Niladhari Division respectively, in Mahapalatha Paththu Minor Division of the Divisional Secretariat Division of Mawanella in Kegalle District, Sabaragamuwa Province and bounded by

01. Lot 'A' – Kalotuwanehena – Extent: 0.0023 Hectare
