### Land Acquisition Notices

#### THE LAND ACQUISITION ACT (CHAPTER 460)

#### **Declaration under Section 5**

I, Gayantha Karunatilleke, Minister of Lands and Parliamentary Reforms, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

Fourty-three (43) allotments of land depicted in the Greater Colombo District Surveyor-General's Advance Tracing No. CO/M/CO/2001/113 dated 07.11.2001, situated in the Village of Kirulapona within the Municipal limits of Colombo in the Divisional Secretary's Division of Thimbirigasyaya in Colombo District of Western Province and bounded as follows:
