#### FILLING OF A VACANCY IN THE OFFICE OF MEMBER OF THE VALIKAMAM SOUTH PRADESHIYA SABHA UNDER SECTION 66A(1)(a) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)

WHEREAS the office of member of Valikamam South Pradeshiya Sabha has fallen vacant by reason of not attending three consecutive meeting without permission ;
