LAND ACQUISITION ACT (CHAPTER 460) AS AMENDED BY THE LAND ACQUISITION (AMENDMENT) ACT, NO. 28 OF 1964

Notice under Section 7

I, hereby give notice under Sub-Section (1) of Section (7) of the Land Acquisition Act as amended by Land Acquisition (Amendment) Act, No. 28 of 1964 that the Government intends to acquire the following land/servitude which are required for a public purpose.
