FOREST CONSERVATION ORDINANCE

The Order under Section 3 that has to be read with Section 64(1) of the Forest Conservation Ordinance (Chapter 451), as No. 13 of 1966, as amended by Acts, No. 56 of 1979, No. 13 of 1982, No. 84 of 1988, No. 23 of 1995 and No. 65 of 2009 that have to be read with Section 51 of the 19th amendment of the Constitution of Democratic Socialist Republic of Sri Lanka.

The Order

By virtue of powers vested in me by Section 3 of the Forest Conservation Ordinance (Chapter 451) as amended by Acts, No. 13 of 1966, No. 56 of 1979, No. 13 of 1982, No. 84 of 1988, No. 23 of 1995 and No. 65 of 2009, that have to be read with Section 51 of the 19th Amendment of the Constitution of Democratic Socialist Republic of Sri Lanka, I Maithripala Sirisena, President do by this Order declare the Katagamuwa Demeda Mukalana Forest of 62.583 hectares bounded by the limit set forth in the Schedule hereto as Katagamuwa Demeda Mukalana Reserved Forest from 18th day of March 2019.

SCHEDULE

The forest area comprising Waanelayaya, Demedekele, Koangahamulayaya, Dambagaha Mukalana, Modaramulle Hena, Demeda Kele and Mandakaliye Doowa called or known as Lot Numbers 375, 376, 378, 379, 381, 382, 383 and 384 of F. V. P. 2969 and Lot Numbers 450, 451, 453, 454, 456, 457, 458 and 459 of F. V. P. 2966 in Katagamuwa village of Nikaweratiya Divisional Secretary's Division in Kurunegala District, North Western Province containing in extent 62.583 ha. [excluding Lot Number 67 (Pita oya), Lot Number 377 (road), Lot Number 380 (road), Lot Number 69 (canal) of F. V. P. 2969, Lot Number 125 (Pita Ela), Lot Number 452 (road) and Lot Number 455 (road) of Forested lands, bounded as follows:

By North : A part of Katagamuwa village of F. V. P. 2969 and a part of Hammillewa village of F. V. P. 2966;

By East : Diwullewa village of F. V. P. 2964 and Deduru Oya of Lot Number 127 of F. V. P. 2966 and

Deduru Oya of Lot Number 71 of F. V. P. 2969;

By South: Lot Number 127 of F. V. P. 2966 and Deduru Oya of Lot Number 71 of F. V. P. 2969;

By West : A part of Katagamuwa village of F. V. P. 2969 and a part of Hammillewa village of F. V. P. 2966.
