#### FOREST CONSERVATION ORDINANCE

THE order under section 3A. that has to be read with Section 64(1) of the Forest Conservation Ordiance (Chapter 451), as No. 13 of 1966, as amended by Acts, No. 56 of 1979, No. 13 of 1982, No. 84 of 1988, No. 23 of 1995 and No. 65 of 2009 that have to be read with Section 51 of the 19th amendment of the Constitution of Democratic Socialist Republic of Sri Lanka.
