I, do hereby give notice under Sub-section (1) of Section 7 of the Land Acquisition Act, that the Government intends to acquire the following land which is required for a public purpose.

#### *Description of the land to be acquired:*

The allotment of land Lot No. 01 in total extent of about 0.0008 hectares, depicted in the Preliminary Plan Maha/6911, surveyed and prepared by the senior surveyor superintendent of Kandy for Surveyor General and situated in the village of Walala in Pallegampaha Korale minor division of Pathadumbara Division in Kandy District, Central Province.
