#### **Declaration under Section 5**

I, Gayantha Karunatilleke, Minister of Lands and Parliamentary Reforms, do hereby declare under the Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below are acquired for a public purpose under the provisions of the Land Acquisition Act
