THE LAND ACQUISITION ACT (CHAPTER 460)

Notice under Section 7

Lands & Parliamentary Reforms Mini's Ref. No.:- 4-3/4 2017/LO/54. My Ref. No.:- DIVPANN/LND/ACDEP/1/4/15.

I hereby give notice, under Sub section (1) of Section 7 of the Land Acquisition Act, No. 28 of 1964 (Amendment) that the Government intends to acquire the following lands which are required for Establishment of the Police Station - Kandanegedara.

Description of the Land to be acquired:

The allotments of land in total extent of 0.8093 Hectare depicted in Supplement No. 12 Sheet No. 10 of F.V.P.292 and in Supplement No. 08 sheet No. 08 F.V.P.293 situated in the Village called Horothepola, Wadumunegedara in Medapattuwa Basnahira Korale in the Divisional Secretary's

Division of Pannala in Kurunegala District of the North Western Province and morefully described as follows.

Name of the Land: Horathepolawatta; Description: Garden, a permanent building, parts of 2 permanent buildings well constructed by cement, 50 coconut trees of 40-45 years old, 25 coconut trees of 20-25 years old, 5 cashew tress, 01 jack tree, mixed cultivation with 32 arecanut trees; Claimant: A.A.I.Jayawardhana residence at No.716/5 Korathota North, Kaduwela; Total Extent: 0.6498 Hectare.
