#### THE LAND ACQUISITION ACT (CHAPTER 460)

#### **Declaration under Section 5**

I, Gayantha Karunatilleke, Minister of Lands and Parliamentary Reforms do hereby declare, under the Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

North: Weeragollayaya claimed by H. P. Rankiri, Elagamuwa reservation belongs to the State; East: Galporugolla ela; South: Galporugolla ela, Weeragollayaya claimed by H. P. Rankiri; West: Weeragollayaya claimed by H. P. Rankiri.
