<i>Duties and Functions</i>	<i>Departments, Statutory Institutions and Public Corporations</i>	<i>Laws to be implemented</i>
1. Formulation, monitoring and evaluation of all SLTDA activities implemented under the Sri Lanka Tourism Development Authority in consultation with the Minister. 2. Ensuring the success of the proposed registration process of informal Sector' who are engaged in tourism illegally throughout the island (eg. Hotels, Restaurants, Guides, Travel Agents <i>ect.</i>) and monitoring together with Sri Lanka Tourism Development Authority the process of being formal entities of such by December 2019. 3. Review and monitoring of the progress of the development and promotional programmes of local tourism activities, (eg. Resorts, Zones, Events <i>etc.</i>) 4. Monitoring and evaluation of programmes implemented at divisional level in relation to Christian Religious Affairs. 5. Development, regulation and supervision of tourist hotels and travel agencies by paying emphasis on classification process of tourist hotels and travel agencies. 6. Maintenance of close and productive relations with Sri Lanka Tourism Development Authority and review, monitoring and evaluation of the progress of it regularly and ensuring the productivity, efficiently specially that of one stop shop, standards and Quality Assurance Division, Research Division <i>etc.</i>

7. As State Minister, being well aware of all activities and affairs of the Ministry, Specially the Sri Lanka Tourism Development Authority coming under the purview of the Ministry. 8. Further implementations of the Sri Lanka Tourism Strategic Action Plan 2017- 2020 together with Sri Lanka Tourism Development Authority. 9. Monitoring the maintenance of Tourist Resorts, Tourism Zones and other tourism attractive properties implemented under the Sri Lanka Tourism Development Authority with a professional value. 10. Monitoring together with Botanical Gardens Department in respect of maintenance of botanical gardens and improvement of floriculture industry in conservation of Sri Lanka's flora. 11. Monitoring the conservation of Wildlife resources. 12. Maintenance of close and productive relations with functions of Department of National Zoological Gardens, Department of National Botanical Gardens, Department of Wildlife Conservation and Wildlife Trust and review, monitoring and evaluation of the progress of such institutions. 13. Any other duty and function assigned by the Minister from time to time in addition to the above mentioned duties and functions.
