## THE LAND ACQUISITION ACT (CHAPTER 460)

I hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, as amended by the Land Acquisition (Ammendment) Act No.28 of 1964, that the Government has intends to acquire the undermentioned land/ Servitude for a public purpose.
