LAND REFORM COMMISSION ACT, No. 1 OF 1972 OF THE NATIONAL STATE ASSEMBLY

Order under Sub-Section (4) of Section 27a

I, Gayantha Karunathilaka, the Minister of Lands and Parliamentary Reforms, by this Order made in terms of powers vested in me by Sub-section (4) of Section 27A of Land Reform Act, No. 1 of 1972 of the National State Assembly as amended by Land Reforms (Special Provisions) Act, No. 39 of 1981.

- (a) Do hereby amend that rule by revoking them on the basis of not adhering to the conditions and orders when vesting the land called Walahanduwa Watta specified in Schedule two here to in Sri Lanka State Plantation Corporation, which had been vested in Sri Lanka State Plantation Corporation established under Sri Lanka State Plantation Corporation Act, No. 4 of 1958 and transferred under Sub-Section (1) of Section 27A of the Land Reform Commission Act, No. 1 of 1972 as published in the *Gazette Extraordinary* No. 815/10 on 21st April, 1994 relevant to the land called and mentioned as Walahanduwa Watta as detailed in the First Schedule hereto.
- (b) Do hereby state that, following this revocation, the said extent of land explained in detail in the Second Schedule hereto is conveyed back to Land Reform Commission.
