Land Acquisition Notices

THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Gayantha Karunatilleke, Minister of Lands and Parliamentary Reforms, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the servitude over the land described below in Paragraph 1 is required for a public purpose and will be acquired under the provisions of that Act. The land over which the said servitude is to be acquired is given in Paragraph 2.

1. **Description of the Servitude**. – Acquisition of servitude over the land, for the construction of Access Road to Pujapitiya Service Reservoir and Pump House of Kandy North - Pathadumbara Intergrated Water Supply Project.

2. **Description of the Land**.– The allotments of land depicted in the Advance Tracing No. Maha/PJP/2015/602 and dated 08.02.2016, prepared by the Surveyor-General, situated in the Villages of Diddeniya and Medagoda in the Minor Division of Pallegampaha Korale in the Divisional Secretary's Division of Pujapitiya in Kandy District, Central Province and bounded as follows:

01. Lot 'A' - Ekkassawatta - Extent: About 0.0066 Hectare

North: Road (R.D.A.) and Ekkassawatta claimed by Eranda Wijerathne; East: Ekkassawatta claimed by Eranda Wijerathne; South: Ekkassawatta claimed by Eranda Wijerathne, Lot C, Ekkassawatta *alias* Ginigewatta claimed by B. M. S. Bandaranayaka and Lot B; West: Ekkassawatta claimed by K. M. W. Sankha Muthu Bandara and Road (R.D.A.).

03. Lot 'C'-Ekkassawatta alias Ginigewatta – Extent: About 0.0136 Hectare

North: Lot A and Ekkassawatta claimed by Eranda Wijerathne; East: Ekkassawatta claimed by Eranda Wijerathne; South: Road and Ekkassawatta *alias* Ginigewatta claimed by B. M. S. Bandaranayaka; West: Ekkassawatta *alias* Ginigewatta claimed by B. M. S. Bandaranayaka and Lot B.
