THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Gayantha Karunatileke, Minister of Lands and Parliamentary Reforms, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

Four allotments of land depicted in the Advance Tracing No. Ma/MNN/2018/159 dated 13.02.2019, prepared by the Surveyor-General, situated in the Village called Thoddaveli in the Grama Niladhari Division No. MN/62 of Thoddaveli in the Divisional Secretary's Division of Mannar Town in Mannar District in Northern Province and bounded as follows:

01. Lot 'A' – Thoddakani – Extent: 0.1850 Hectare

North: Thoddakani, claimant not known; East: Thoddakani, claimant not known, Thoddakani claimed by Four Teess Rest Inn and Lots B and C; South: Lots B, C and D; West: Lot D and Thoddakani, claimant not known.

02. Lot 'B' – Thoddakani – Extent: 0.4560 Hectare

North: Lot A, Thoddakani, claimant not known and Thoddakani claimed by Four Teess Rest Inn; East: Thoddakani claimed by

Four Teess Rest Inn and Road (R.D.A.); South: Road (R.D.A.) and Lot C; West: Lots C and A.

03. Lot 'C' – Thoddakani – Extent: 0.4560 Hectare

North: Lots A and B; East: Lot B and Road (R.D.A.); South: Road (R.D.A.) and Lot D; West: Lots D and A.

04. Lot 'D' – Thoddakani – Extent: 1.1030 Hectare

North: Thoddakani, claimant not known and Lots A and C; East: Lots A and C and Road (R.D.A.); South: Road (R.D.A.) and Road (Pradeshiya Sabha); West: Road (Pradeshiya Sabha) and Thoddakani, claimant not known.
