I, Isura Devapriya, the Chief Minister of Western Province and the Minister of Finance and Planning, Engineering Services, Law and Order, Local Government and Provincial Administration, Economic Promotions, Power and Energy, Environmental Affairs, Water Supply and Drainage and Tourism of Western Province do hereby notify that permission is granted under and by virtue of powers vested in me by provision of Section 2(2) of the Entertainment Tax Ordinance No. 12 of 1946 that has to be read with Section 2 of Provincial Councils (Consequential Provisions) Act, No. 12 of 1989, to impose and recover the entertainment tax of 15% out of the entrance fee that is recovered for the entertainment activities as per terms of expression in Entertainment Tax Ordinance No. 12 of 1946, that is amended by (Amendment) of Entertainment Tax Act, No. 37 of 1984, however as per provisions of Section 2(1) of Entertainment Tax Ordinance No. 12 of 1946, the resolution that has been passed in the meeting held on 19.07.2018 in the Pradeshiya Sabha of Homagama, to impose and recover 10% of the entertainment tax, for the displays those are displayed in the cinema halls, which fall within the administrative limit of Homagama Pradeshiya Sabhawa.
