AMENDMENT OF IMMIGRANTS AND EMIGRANTS REGULATIONS 1956 RELATED TO THE IMMIGRANTS AND EMIGRANTS ACT, No. 20 OF 1948

BY virtue of powers vested in me under section 52 that should be read in conjunction with the section 23 of the Immigrants and Emigrants Act pertaining to the Ministerial subject assigned to me, I Wajira Abeywardana as the Minister of Internal & Home Affairs and Provincial Councils & Local Government and as per the Cabinet Memorandum No. 8/IA/2019 dated 31.01.2019 submitted by me on “Amendments to be made to the Immigrants and Emigrants Regulations for existing visa categories and to revise relevant fee in the visa Issuing system of the Department of Immigration and Emigration”, the revised Regulations pertaining to the Immigrants and Emigrants Act, No. 20 of 1948 (Chapter 351) attached to the aforesaid Cabinet Memorandum are submitted herewith and I do hereby order to publish the amended regulations in the Government Gazette and subsequently to table the same in the Parliament for approval.

IMMIGRANTS AND EMIGRANTS ACT (Chapter 351)

REGULATIONS made by the Minister of Internal and Home Affairs and Provincial Councils and Local Government under Section 52, read with Section 23 of the Immigrants and Emigrants Act, (Chapter 351) and approved by Parliament.

Regulations

The Immigrants and Emigrants Regulations 1956, published in the Supplement to the Ceylon Government *Gazette* No. 10,896 of February 24, 1956 are hereby amended as follows :-

1. in regulation 8 -

- (1) in paragraph (1) by the substitution for the words “ furnish such Number of copies of the photograph or of the finger- prints or of both,” of the words “ furnish such Number of copies of the photograph or of the bio metrics or of both,”;
- (2) in paragraph (2), by the substitution for the words, “or of the finger-prints furnished” of the words, “ or of the bio metrics furnished”.

2. by the insertion immediately after regulation 10, of the following new regulation :-

“10A. (1) Any person who contravenes the condition which specifies the period of stay in any visa granted or issued to that person, by overstaying in Sri Lanka, shall be required to pay a penalty of United States Dollars 500, in addition to the applicable visa fee for the period of over stay.

(2) Notwithstanding the provisions of paragraph (1), the prescribed Authority may grant a grace period -

- (a) of two days at the port of departure to a person referred to in paragraph (1) ; or
- (b) seven days when applying for an extension of the period of stay specified in the visa from the Department of Immigration and Emigration.

3. by the substitution, for regulation 13 thereof, of the following regulation :-

“13. (1) The fees payable in respect of visas shall be as set out in the table below :-

Provided however, that no fee shall be payable for the grant or issue of a visa to any person who -

- (a) is the holder of a diplomatic or official passport ; or
- (b) is the holder of a valid diplomatic or official endorsement on his passport.

(2) Notwithstanding anything to the contrary in Paragraph (1) -

- (a) a national of a country (other than Sri Lanka) may be required to pay for a visit visa or transit visa, a sum not exceeding the amount that a citizen of Sri Lanka would be liable to pay for a visa for that country ; and
- (b) where a visit visa or a transit visa is granted or issued to any person by the representative of another Government on behalf of the Government of Sri Lanka, such person may be required to pay for that visa any sum fixed between the two Governments.

4. In regulation 15, by the substitution for the word “to any person for such period not exceeding six months” of the words “to any person for a single journey or for several journeys for such period not exceeding nine months.”
