### Land Acquisition Notices

#### THE LAND ACQUISITION ACT (CHAPTER 460)

#### **Declaration under Section 5**

I, Gayantha Karunatilleke, Minister of Lands and Parliamentary Reforms, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that servitude of the land described below in Paragraph 1 is required for a public purpose and will be acquired under the provisions of that Act. The land over which the said servitude is to be acquired is given in Paragraph 2.

1. Description of the Servitude .- For Access Road to Tennekumbura Service Reservoir of the Kundasale - Haragama Water Supply Project.

2. Description of the Land.- The allotments of land called Semaneriya Estate and Tennekumbura Estate depicted in the Advance Tracing No. Maha/MHN/2017/262 and dated 14.09.2017, prepared by the Surveyor-General, situated in the Villages of Semaneriya Watta and Thannekumbura in the Grama Niladhari Divisions No. 269 Ampitiya North and No. 275 Thennekumbura in the Minor Division of Gangawata Korale in the Divisional Secretary's Divisions of Kadawathsathara and Gangawata Korale in Kandy District, Central Province and bounded as follows:
