#### THE LAND ACQUISITION ACT (CHAPTER 460)

#### **Declaration under Section 5**

I, Gayantha Karunatilleke, Minister of Lands and Parliamentary Reforms Ministry hereby declare under Sub-section (1) of section 5 of the Land Acquisition Act. That the land described below is needed for the public purpose and will be acquired under the provisions of the Act.
