REVOCATION ORDER UNDER SECTION 39 (1)

1. **Description of the Land.**– Allotment of land called Voganwaththa - Deegalla Division in total extent of about 0.3224 Hectare depicted in the Advanced Tracing No. Ka/DDN/12/55 dated 26.09.2012 prepared by the Surveyor General, situated in the Village called Nebada in the Divisional Secretary's Division of Dodangoda in Kalutara District of Western province and bounded as follows:
