Land Acquisition Act, (chapter 460), as amended by the Land Acquisition (Amendment) Act, No. 28 of 1964 that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

The allotments of lands in total extent of 4.103 Hectares depicted in Advance Tracing No. GA/AKM/06/178 dated 16.02.2006 as Lots A and B, prepared by the Surveyor General, situated in the Village of Ankokkawala, in the Grama Niladhari Division of 110, Ankokkawala in the Divisional Secretary's Division of Akmeemana, in the District of Galle, Southern Province.
