Declaration under Section 5

My Ref. No.: 4-3/6/2018/HW/21.

I, Gayantha Karunatilleke Minister of Lands & Parliamentary Reforms, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the Land described below is needed for a public purpose and will be acquired under the provisions of that Act.
