SPECIAL COMMODITY LEVY ACT, No. 48 OF 2007

Order under Section 2

BY virtue of the powers vested in me under Section 2 of the Special Commodity Levy Act, No. 48 of 2007, I, Mangala Samaraweera, Minister of Finance of the Democratic Socialist Republic of Sri Lanka, do by this order impose in respect of the list of commodities specified in Column I of the Schedule hereto, a Special Commodity Levy at the rates specified in the corresponding entries in Column II of that Schedule.

This Order shall be valid for a period of thirty one days commencing from July 11, 2019, subject to provisions of Sub Section (3) of Section 2 of the Special Commodity Levy Act, No. 48 of 2007.

The Order made under Section 2 of the Special Commodity Levy Act, No. 48 of 2007 and published in the *Extraordinary Gazette Notification* No. 2111/58 of 24.02.2019 and the *Extraordinary Gazette Notification* No. 2124/2 of 21.05.2019 in respect of Dates (HS Codes 0804.10.10, 0804.10.20) and the *Extraordinary Gazette Notification* No. 2090/47 of 29.09.2018 in respect of Oranges (HS Codes 0805.10.10) and Apples (HS Codes 0808.10) are rescinded with effect from July 11, 2019.
