#### THE LAND ACQUISITION ACT (CHAPTER 460)

#### **Declaration under Section 5**

I , Gayantha Karunatilleke Minister of Lands and Parliamentary Reforms, do hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the Lands described below are needed for a public purpose and will be acquired under the provisions of that Act.
