THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Gayantha Karunatileke, Minister of Lands and Parliamentary Reforms, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

Four (04) allotments of land, depicted in Advance Tracing No. H/BLA/RDA/2018/355 and dated 26.07.2018, prepared by the Surveyor - General, situated in the Village of Mahaheella (F. V. P. 297) in the Minor Division of Giruwapattuwa South in the Divisional Secretary's Division of Beliatta in Hambantota District in Southern Province and bounded as follows:

01. Lot 'A' - Ginigalpalahena, Namanethigahawatta - Extent: 0.0012 Hectare

North: Lot No. 784, 783, 774 and Lot B; East: Lot B; South: Lot No. 785; West: Lot No. 785 and 784.
