Government Notifications

Land Reforms Act, No. 01 of 1972 of the National State Assembly

By virtue of the powers vested in me by the Section 27 A (4) of the Land Reform Law No. 01 of 1972 of the National State Assembly as amended by the Land Reform (Special Provisions) Act, No. 39 of 1981 and to be read together with Sub Article (2) of Article 44 of the Constitution of the Democratic Socialist Republic of Sri Lanka I, Gayantha Karunatilleke, Minister of Lands and Parliamentary Reforms of the Democratic Socialist Republic of Sri Lanka, do hereby:

- (a) The allotment of land published in the *Gazette Extraordinary* No. 403/18 dated 30th May 1986 in total extent of 282 acres 02 roods 28 perches depicted in the Plan No. Gam 148 prepared by the Licensed Surveyor, Mr. Ranasinghe Thambugala on 30.09.1983, more fully described in the First Schedule hereto and alienated to the National Housing Development Authority, established by the Act, No. 17 of 1979 as amended by the Acts, No. 5 of 1982, No. 20 of 1988, No. 30 of 1999, No. 23 of 2002, No. 32 of 2003, is the land called Pokunawala Watta *alias* Ran Pokuna Watta, which has been alienated under Sub Section (1) of Section 27a of the Land Reform Law.
- (b) Amend that order by revoking the aforesaid orders made for divesting the allotment of private land in extent of 01 acre 01 rood 11 perches claimed by Kosala Samith Liyanage relatiting to the land called and known as Pokunawala Watta alias Ran Pokuna Watta more fully described in the 2nd Schedule, identified as included in the aforesaid land described more fully in the First Schedule hereto.



Further, I do hereby declare that upon this revocation, the extent of land depicted in detail in 2nd Schedule hereto shall be divested to the Original Claimant.
