##### REVOCATION UNDER SECTION 39(1)

The allotment of land described in detail in the Order No. 189 of 2002 dated 11.11.2002 made under the Proviso (a) to Section 38 of the Land Acquisition Act (Chapter 460) and published in the Gazette Extra Ordinary No. 1262/26 dated 15.11.2002 is vested in the Democratic Socialist Republic of Sri Lanka.
