THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Gayantha Karunatilleke, Minister of Lands and Parliamentary Reforms, do hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

The allotments of lands depicted in the Advance Tracing No. B/ACQ/BDL/2016/65 and dated 11.03.2016, prepared by the Surveyor-General, situated in the Village of Badulla town (Badulupitiya Grama, Division No. 08) in the Grama Niladhari Division of Badulupitiya (78J) in the Minor Division of Rilpola Korale in the Divisional Secretary's Division of Badulla in Badulla District in Uva Province and bounded as follows:

01. Lot 'A' - Extent: 0.0370 Hectare
