Land Acquisition Notices

THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Gayantha Karunatilleke, Minister of Lands and Parliamentary Reforms, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the servitude described below in Paragraph 1 is required for a public purpose and will be acquired under the provisions of that Act. The land over which the said servitude is to be acquired is given in Paragraph 2.

1. **Description of the Servitude**.– Servitude to be obtained under the Asia Development Bank 5 project, acquiring a block of land for the pipe line for waste water in the Bangadeniya water storage tank.

2. **Description of the Land.**– Two (02) allotments of land called Kumbutukuliya depicted as Lots 'A' and 'B' in the Advance Tracing No. PU/ARC/2017/161 dated 31.05.2017, prepared by the Superintendent of Surveys in charge of the Division of Puttlam and situated in the Village of Kumbutukuliya in the Minor Division of Munnessaram in the Divisional Secretary's Division of Arachchikattuwa, Puttlam District of North Western Province and containing to total extent of 0.0120 Hectare and bounded as follows:

01. Lot 'A' – Kumbutukuliya Watta – Extent: 0.0042 Hectare

North: Kumbutukuliya Watta claimed by M. M. G. Hayasintha Costa and Kumbutukuliya Road; East: Kumbutukuliya Watta claimed by M. M. G. Hayasintha Costa and Lot B; South: Lot B and Kumbutukuliya Watta claimed by Chandrasiri Mayakaduwa; West: Kumbutukuliya Watta claimed by Chandrasiri Mayakaduwa and Kumbutukuliya Watta.

02. Lot 'B' – Kumbutukuliya Watta – Extent: 0.0078 Hectare

North: Kumbutukuliya Watta claimed by Chandrasiri Mayakaduwa, Lot A and Kumbutukuliya Watta claimed by M. M. S. Hayasintha Costa; East: Kumbutukuliya Watta claimed by J. A. D. Shelton Appuhami; South: Kumbutukuliya Watta claimed by J. A. D. Shelton Appuhami and Road; West: Road, Kumbutukuliya Watta claimed by J. A. D. Shelton Appuhami and Kumbutukuliya Watta claimed by Chandrasiri Mayakaduwa.
