I, hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, as Amended by the Land Acquisition (Amendment) Act, No.28 of 1964, that the Government intends to acquire the land described below under Greater Colombo Flood Control and Environment Promotion Project.
