#### ORDER

By virtue of the powers vested in me by under Section 2 of the Revenue Protection Act, No. 19 of 1962, I, Mangala Samaraweera, Minister of Finance, the Democratic Socialist Republic of Sri Lanka do by this Order from 28th



September, 2019, require the Director General of Customs do demand and lvey on each article specified in Column 3 of the Schedule hereto, import duty at the general rate set out in the corresponding entries in Column 5 of that Schedule, or where a preferential rate is leviable and payable under the Provisions of Schedule “A” of the Customs Ordinance (Chapter 235), at the preferential rates set out in the corresponding entry in Column 4 of that Schedule.
