Limited, a company incorporated in Sri Lanka under the Companies Act, No. 7 of 2007 and bearing registration Number PV 101137, do by this Order, amend the Schedule II to the Order made under the said Act, and published in *Gazette Extraordinary*, No. 2121/44 of May 2, 2019 by the addition immediately after the entry "Bachelor of Business Management Honours in Human Resource Management" appearing in Column I and it's this corresponding entry in Column II thereto, of the entries specified under Column I and II respectively of the Schedule II hereto, subject to the conditions specified in Schedule I hereto:-

Conditions

- (iii) the Bachelor of Technology Honours in Agricultural Technology, adhere to the minimum entry qualification of three (3) simple passes ('S') in physical science, biological science or technology subject stream in one and the same sitting at the GCE (Advanced Level) Examination or equivalent.

Limited, a company incorporated in Sri Lanka under the Companies Act, No. 7 of 2007 and bearing registration Number PV 94125, do by this Order, amend the Schedule II to the Order made under the said Act, and published in *Gazette Extraordinary*, No. 1944/2 of December 7, 2015, by the addition immediately after the entry "Master of Philosphy in Buddhist Studies" appearing in Column I and it's corresponding entry in Column II thereto, of the entries specified under Column I and II respectively of the Schedule II hereto, subject to the conditions specified in Schedule I hereto:-

Conditioins

- 1. Nagananda International Institute for Buddhist Studies (Pvt.) Limited is recognized to offer the degree specified in Schedule II hereto subject to the five (5) year re-review conducted by the Specified Authority.

 - (d) the successful completion of the SLQF Level 6 in the Bachelor's Honours Degree in any recongnized University or Higher Education Institution in the relevant area of study with valid registration to follow a Master of Philosophy (MPhil.) at Nagananda International Institute for Buddhist Studies (Pvt) Limited, which may be upgraded to Doctor of Philosophy (PhD) level after a minimum period of one year, where the research competencies of such person are of exceptional merit; or
 - (e) the successful completion of the SLQF Level 5 in the Bachelor's Degree in any recongnized University or Higher Education Institution in the relevant area of study with a minimum GPA of 3.0 at a scale of 0-4 and the successful completion of a qualifyin examination conducted after completion of 30 credits equivalent to SLQF Level 6, with valid registration to follow a Master of Philosophy (MPhil.) at Nagananda International Institute for Buddhist Studies (Pvt) Limited, which may be upgraded to Doctor of Philosophy (Phd) level after a minimum period of one year, where the research competencies of such person are of exceptional merit.
