Rathnasiri and accident of employee Hemal Jagath Kumara that had occurred while being engaged in a 33,000 high voltage maintenance duty in the Customer Service Centre area of Ingiriya on 31.01.2013 had been given relief following their appeal against the punishments given and if such injustice had been caused, to what relief he is entitled.
