#### THE LAND ACQUISITION ACT AS AMENDED BY THE LAND ACQUISITION (AMENDMENT) ACT, NO. 28 OF 1964 (CHAPTER 460)

##### Notice Under Section 7

I hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, No. 28 of 1964 (Amendment) that the Government intends to acquire the following land which is required for a public purpose:

Public purpose: - For the Construction of Kiriella Vidatha Resource Center.

##### *Description of the Land to be acquired :*

The allotment of land depicted as Lots 742, 743, 744 in sheet No. 36 supplement No. 39 of F. V.
