FILLING OF A VACANCY IN THE OFFICE OF MEMBER OF THE YATINUWARA PRADESHIYA SABHA UNDER SECTION 66A(1)(a) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)

WHEREAS the office of member of Yatinuwara Pradeshiya Sabha has fallen vacant by reason the post has been ceased by the governor under Article 185 of Pradeshiya Sabha Act ;

And whereas the Secretary of the Sri Lanka Podujana Peramuna the recognized political party to which Amukotuwe Gedara Sapumal Deshappriya Amukotuwa the member belonged, was required by me under Section 66A(1)(a) of the aforesaid Ordinance to decide upon the member of that number 05 Dodanwala of Yatinuwara Pradeshiya Sabha who belongs to such party and is not disqualified under Section 9 of the Local Authorities Elections Ordinance (Chapter 262) and who shall be declared elected as a member within a period of thirty (30) days ;

And whereas the Secretary of the aforesaid recognized political party has communicated his decision to nominate Hewa Bambarandage Anuruddha Shantha Bandara to fill such vacancy ;

Now therefore I, Talangama Appuhamilage Chaminda Namal Talangama, returning officer of the Yatinuwara Pradeshiya Sabha, acting in terms of Section 66A(1)(a) of the Local Authorities Elections Ordinance (Chapter 262) do hereby declare that Hewa Bambarandage Anuruddha Shantha Bandara was elected as the member of the number 05 Dodanwala of Yatinuwara Pradeshiya Sabha.
