### THE LAND ACQUISITION ACT (CHAPTER 460)

#### **Declaration under Section 5**

I, Samarakoon Mudiyanselage Chandrasena, Minister of Lands hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

The boundaries of the plots of land situated in the Village of Lower Makandura in the Lower Makandura Grama Niladhari Division No. 1589, Pannala Divisional Secretariat, Kurunegala District, North Western Province, as per the Advance Tracing No. KU/PNN/2015/698 dated 06.06.2016 prepared by the Surveyor General are as follows:

#### 01. Lot 'A' – Bakmeegahakumbura – Extent: 0.5214 Hectare

North: Canal; East: Road; South: Canal and Gamage Kumbura owned by M. M. S. Channa Munasinghe; West: Lot B.
