#### EASTERN PROVINCE PROVINCIAL COUNCIL

##### Announcement

I, Anuradha Yahampath, Governor of the Eastern Province, do hereby amend the Sections referred below in the Regulations published in the *Extraordinary Gazette* of the Democratic Socialist Republic of Sri Lanka, No. 2184/9 dated 13th July 2020 in relation to allowances for Councilors of Municipal Council, Urban Council and Pradeshiya Sabha in the Eastern Province. The amendments shall be effected from 23rd June, 2020.

##### Regulations

#### 01. Municipal Council

Sub-section 1.1 of the Regulations for Municipal Council published in the *Extraordinary Gazette* of the Democratic Socialist Republic of Sri Lanka No. 2184/9 dated 13th July 2020 is hereby repealed and replace with the following sentences.



**1. Fuel Limits to Mayor of Municipal Council for official visits :**

- 1.1 If a vehicle of Municipal Council is used within or outside of the municipality limit, monthly fuel consumption of diesel/petrol limit for such purposes shall be approved by the Council and paid from the Council funds.

**02. Urban Council**

Sub-section 1.1 of the Regulations for Urban Council published in the *Extraordinary Gazette* of the Democratic Socialist Republic of Sri Lanka No. 2184/9 dated 13th July 2020 is hereby repealed and replace with the following sentences.

**1. Fuel Limits to Chairman of Urban Council for official visits :**

- 1.1 If a vehicle of Urban Council is used within or outside of the Urban Council limit, monthly fuel consumption of diesel/petrol limit for such purposes shall be approved by the Council and paid from the Council funds.

**03. Pradeshiya Sabha**

Sub-sections 1.1, 1.2 and 1.3 of the Regulations for Pradeshiya Sabha published in the *Extraordinary Gazette* of the Democratic Socialist Republic of Sri Lanka No. 2184/9 dated 13th July 2020 is hereby repealed and replace with the following sentences.

**1. Fuel Limits to Chairman of Pradeshiya Sabha for official visits :**

- 1.1 If a vehicle of Pradeshiya Sabha is used within or outside of the Pradeshiya Sabha limit, monthly fuel consumption of diesel/petrol limit for such purposes shall be approved by the Pradeshiya Sabha and paid from the Sabha funds.
