PART I : SECTION (I) — GENERAL

Government Notifications

SRI LANKA EXPORT DEVELOPMENT ACT, No. 40 OF 1979

Order under Section 14

BY virtue of the powers vested in me by Section 14 of the Sri Lanka Export Development Act, No. 40 of 1979, I, Bandula Gunawardane, Minister of Trade, with the concurrence of the Minister of Finance, do by this Order declare to:-

A. Amend the Order made in the *Gazette* Notification No. 2047/2 of November, 27, 2017, as amended, by,

(1) Addition of the following new sub paragraphs immediately after sub paragraph (xvii) of the paragraph (2).

- “(xviii) Health protection equipment and similar products supplied or donated by any export-oriented enterprises which have entered into an agreement with the Board of Investment of Sri Lanka under Section 17 of the Board of Investment Law, No. 04 of 1978, to the Ministry of Healthcare and Indigenous Medical Services, Department of Health Services, Sri Lanka Army, Sri Lanka Navy, Sri Lanka Air Force, Sri Lanka Police and COVID Centre (National Operation Centre for Prevention of COVID-19 Outbreak) on their request.
- (xix) Machinery and equipment including medical, surgical, and dental instruments, apparatus, accessories and parts thereof, hospital/medical furniture and drugs, chemicals and similar items, required for the provision of health services to address the COVID-19 Pandemic in the country, imported or imported and supplied or imported and donated to the Secretary, Ministry of Healthcare and Indigenous Medical



Services, on the recommendation of the Secretary, Ministry of Healthcare and Indigenous Medical Services subject to approval of the Director General of Customs. It shall not be granted for any partial consignment/cargo of the above and only valid until December 31, 2020.”

- (2) Addition at the end of the Schedule of the articles specified in the Column III corresponding to the HS Headings and HS Codes specified in the Column I and II of the Schedule I hereto.
- (3) Amendment of the rates specified in the Column IV of the Schedule by inserting rates specified in the corresponding entry in the Column IV of the Schedule II hereto,

B. This Order shall come into effect from November 01, 2020.
