Revocation order under Section 39 (1)

BY the Order made under the Proviso (a) to Section 38 of the Land Acquisition Act, (Chapter 460) and published in the *Gazette Extraordinary* No. 2028/46 dated 20.07.2017 and the land specified more fully in the Order No. 169 of 2017 dated 17.07.2017 amended by the correction paper published in the *Gazette Extraordinary* No. 2033/5 dated 21.08.2017 was vested in the Democratic Socialist Republic of Sri Lanka.
