#### LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Samarakoon Mudiyanseelage Chandrasena, Minister of Lands do hereby give notice that it intends to acquire the following lands that necessary for a public purpose under Sub-section (1) of Section 5 of the Land Acquisition Act.
