#### NOTICE UNDER SECTION 3(1) OF THE REGISTRATION OF ELECTORS (SPECIAL PROVISIONS) ACT, No. 10 OF 2017

##### SUPPLEMENTARY REGISTER OF ELECTORS - 2019

FOR THE SRI LANKAN CITIZENS WHO HAVE BEEN INTERNALLY DISPLACED AS A RESULT OF ANY ACTIONS OF A TERRORIST MILITANT OR OTHER GROUP DURING THE RECENT PAST AND WHOSE NAMES HAVE NOT BEEN REGISTERED AS ELECTORS ELSEWHERE IN THE ISLAND

NUMBER AND NAME OF THE ELECTORAL DISTRICT: 11-VANNI

IN terms of Section 3(1) of the Registration of Electors (Special Provisions) Act, No. 10 of 2017, it is hereby notified that the preparation of the supplementary register for displaced persons of the aforementioned electoral district has now been completed and it is now open for inspection by the general public during office hours at **Mannar / Vavuniya/ Mullaitivu** District Election Office.

2. Any person who is eligible under the aforesaid Special Provisions Act to be registered in the supplementary register for the aforementioned electoral district but whose name does not appear in the said register, may appeal in writing to the Registering Officer on the format set out in the aforesaid Registration of Electors Act, in order to have his/her name entered or retained as the case may be in the register. Every appeal in this regard should be made so as to reach the Registering Officer of **Mannar / Vavuniya/ Mullaitivu** District Election Office within two weeks from the date of this notice published in the Gazette of the Democratic Socialist Republic of Sri Lanka.

This notice will be exhibited at the **Mannar / Vavuniya/ Mullaitivu** District Election Office from 01<sup>st</sup> February 2020 to 14<sup>th</sup> February 2020 (including both days).

Any person whose name is included in the aforesaid supplementary register for the aforementioned electoral district may object to the entry or retention of his/her own name or that of any other person in the register. Every objection should be made in writing in duplicate and should be substantially in Form “C” set out in the aforesaid Act and be submitted to the Registering Officer of **Mannar / Vavuniya/ Mullaitivu** District Election Office within two weeks from the date of this notice published in the *Gazette* of the Democratic Socialist Republic of Sri Lanka.

4. Forms to make a claim, to enter or retain a name in the register or to submit objections to any claim to enter or retain any name in the register may be obtained from the aforesaid Election Office of the administrative district of **Mannar / Vavuniya/ Mullaitivu**.
