#### THE CONSTITUTION OF THE DEMOCRATIC SOCIALIST REPUBLIC OF SRI LANKA

Delegation of Powers by the National Police Commission in terms of Article 155 J

BY virtue of the powers vested in the National Police Commission in terms of Article 155J of the Constitution of the Democratic Socialist Republic of Sri Lanka, the said National Police Commission delegated some of its powers to the Inspector General of Police and Police Officers as specified in the Government *Gazette Extraordinary* bearing No. 2016/6 dated April 24, 2017.
