I hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, that the Government has intends to acquire the following land which is required for a public purpose.

Description of the Land to be acquired:

One allotment of land called Indurambavila Atanikitha Division in extent about 2.0047 Hectare depicted as Lot No. 01 in P. P. N. 4286 and dated 05.12.2019 prepared by the Surveyor General situated in Grama Niladhari Division of Atanikitha in the Divisional Secretary's Division of Imaduwa in Galle District of the Southern Province morefully Described as follows:
