THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Samarakoon Mudiyanselage Chandrasena, Minister of Lands and Land Development do hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

The alloments of lands depicted in Advance Tracing No. NU/HKT/2019/242 and dated 07.08.2019, prepared by the Senior Superintendent of Surveys in Nuwaraeliya District on behalf of the Surveyor General, situated in the Village of Padiyapellala in the Minor Division of Udugampaha Korale, in the Divisonal Secretary's Division of Haguranketha in Nuwaraeliya District in Central Province and bounded as follows:

01. Lot 'A' - Welangahayata Thenne Idama - Extent: 0.0027 Hectare

North and East: Road; South: Land claimed by K. M. G. Punchi Banda; West: Balance portion of same land.

02. Lot 'B' - Palliye Kumbura - Extent: 0.0092 Hectare

North: Balance portion of same land; East: Balance portion of same land and Lot C; South: Lots C, D, E and Road; West: Road.

03. Lot 'C' - Palliye Kumbura - Extent: 0.0020 Hectare

North and East: Balance portion of same land; South: Lot D; West: Canal.

North: Lot C and Balance portion of same land; East: Belihul Oya; South and West: Canal.

05. Lot 'E' - Welangahayata Thenne Kubura - Extent: 0.0022 Hectare

North: Lot B; East: Canal; South: Canal and Road; West: Road.

06. Lot 'F' - Welangahayata Thenne Aswedduma - Extent: 0.0084 Hectare

North: Canal; East: Canal and Lot G; South: Lot G and Road; West: Road.



07. Lot 'G' - Welangahayata Thenne Aswedduma - Extent: 0.0233 Hectare

North: Lot F and Canal; East: Canal and Lot I; South: Lot I, land claimed by N. N. P. G. Sumith Nandana and Road; West: Road, Lot H and Road.

$08.\ Lot\ {\bf `H'}$ - Welangahayata Thenne Aswedduma - Extent: 0.0030 Hectare

North, East and South: Lot G; West: Road.

09. Lot 'I' - Welangahayata Thenne Aswedduma - Extent: 0.0005 Hectare

North: Lot G and Canal; East: Canal; South and West: Balance portion of same land.

$10.\ Lot\ 'J'$ - Welangahayata Thenne Aswedduma - Extent: 0.0011 Hectare

North: Lot A and Road; East: Road; South and West: Balance portion of same land.
