1. Acquiring Officer.— Divisional Secretary, Wattala.

2. Description of the land .— The allotments of land described in below names and extent depicted in the Advance Tracing No.: GA/DSO/2019/644 dated of 16.12.2019 was prepared by Surveyor-General, situated in the Village of Maththumagala, in the Grama Niladari Division of No. 177, Maththumagala of the Divisional Secretary's Division of Wattala, in the Gampaha District in Western Province and bounded as follows :

1. Lot 'A' – Jawage Kotuwa – Extent: 0.0566 Hectare

North: Claimer and the Name Not Known Land ; East: Balance portion of this land and Road (Road Development Authority); South: Road (Road Development Authority); West: Claimer and the Name Not Known Land.

2. Lot 'B' – Jawage Kotuwa – Extent: 0.0768 Hectare
