THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Samarakoon Mudiyanse Chandra Sena, Minister of Lands and Land Development, do hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

The allotments of lands depicted in the Advance Tracing No. Ma/DMB/2018/374 dated 09.08.2019 prepared by the Surveyor-General, situated in the Village called Indigollewa in the Grama Niladhari Division, No. E 445 A of Rathmalgahaela in the Divisional Secretary's Division of Dambulla in Matale District in Central Province and bounded as follows:
