### NATIONAL GEM AND JEWELLERY AUTHORITY ACT, No. 50 OF 1993

Regulations made by the Minister of Industries and Supply Chain Management under section 53 read with section 15 of the National Gem and Jewellery Authority Act, No. 50 of 1993.

### Regulations

1. These regulations may be cited as the Gem and Jewellery (License fee) Regulations No. 1 of 2020.
2. The National Gem and Jewellery Authority shall levy a fee for the issuance, renewal; extension or amendment of any license, certificate, permit or approval or other services rendered by the National Gem and Jewellery Authority to any person carrying on the gem industry.
3. The fees specified in column II of the Schedule hereto shall be levied in respect of matters specified in the corresponding entry in Column I of that Schedule.
